NO SMOKING IN PECK BUILDING--Faculty and staff are requested to observe University regulations which prohibit smoking in the Peck Building. During the unfortunate strike situation last week cooperation was excellent. Please continue to cooperate so that health, safety and sanitary standards can be maintained. Your help in observing this regulation will be greatly appreciated.

IDENTIFICATION CARD POLICY--The Southern Illinois University at Edwardsville Photo Identification Card is the approved identification for students, faculty and staff and should be carried at all times while on the University premises. A validated card will be required to obtain services from the Bursar's Office, University Center, University Library, Health Service, admission to intercollegiate athletic events and other campus programs including participation in intramural and recreational activities. In addition, University Security personnel are authorized to request the photo I-D card in conjunction with the conduct of their duties when circumstances warrant identification. The photo I-D is non-transferrable and void if altered. Use by any person of an altered card or use of a card with intent to defraud may constitute a violation of Sections 17-1 or 17-3 of the Illinois Criminal Code (the felonies of deceptive practice and forgery). Each photo identification card is the property of Southern Illinois University at Edwardsville and must be surrendered upon withdrawal or termination from the University.

The card must be presented by students in conjunction with a paid fee receipt card to obtain textbooks from Textbook Rental. Under certain circumstances, additional identification (i.e. drivers license, fee card, etc.) may be required. Misuse (by defacement, alteration, and other means) constitutes an infraction of Sections A-4 and A-7 of the Student Rights and Conduct Code and provides grounds for separation from the University by suspension, dismissal, or expulsion. Students' identification cards must be validated quarterly.

Proper use of the card is a University policy and practice which University faculty and staff employees will be expected to honor pursuant to Article VIII, Section 3 of University Statutes. Faculty and staff identification cards must be validated annually.

Specific dates and locations for taking of faculty and staff pictures for the new ID cards will be announced later.
