

SUBJECT: Administrative Organization of The University

I. Major elements of an administrative realignment at SIUE were approved by the SIU Board of Trustees, March 11. Since that time, a number of reporting line adjustments have been made administratively which do not require formal Board action for implementation. We believe these refinements and the formation of two advisory councils will help accomplish our long-range goals of increased efficiencies while more fully meeting the human and academic needs of the University.

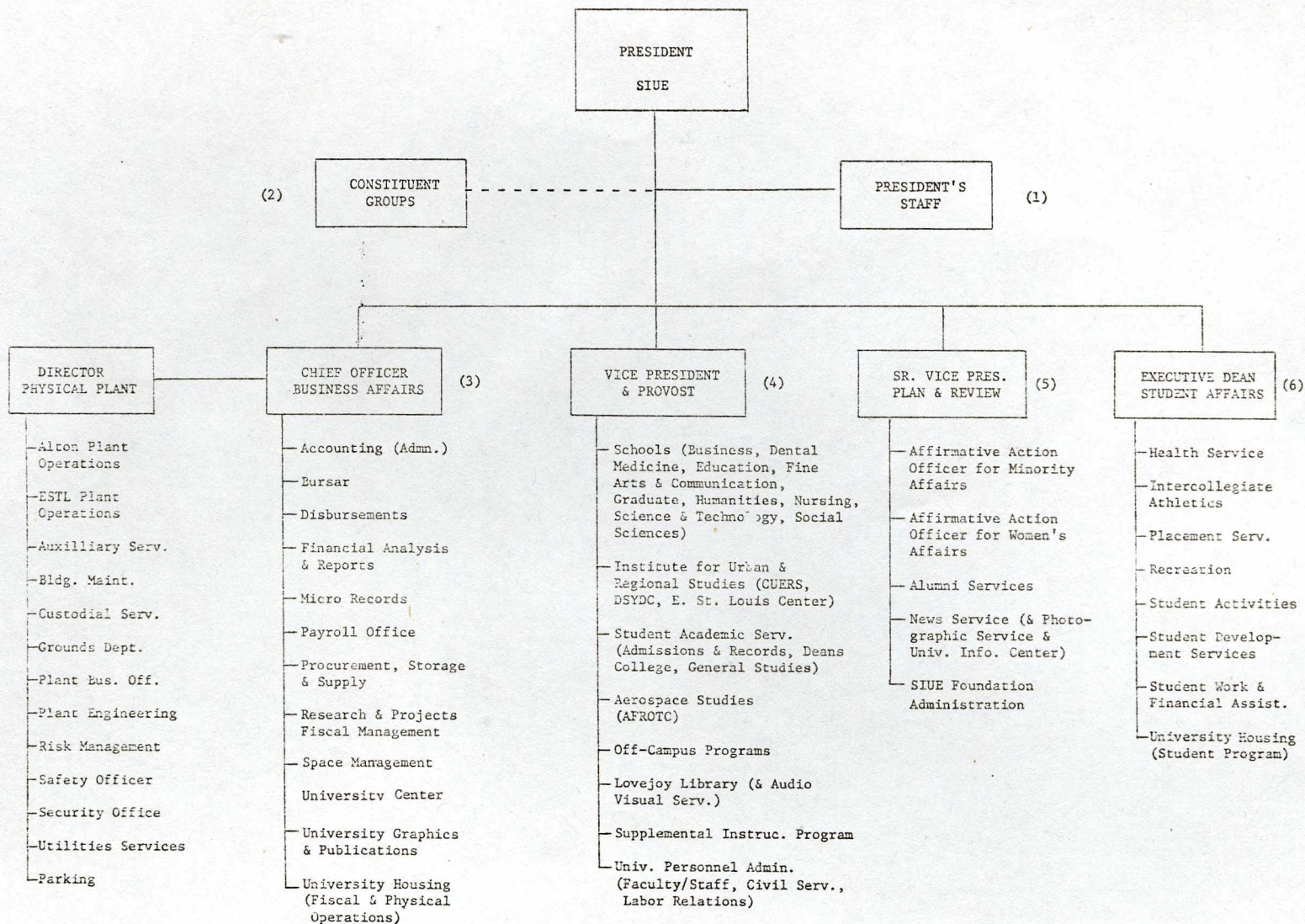
Attached are documents which will explain the organization and introduce the personnel of the Office of The President as well as indicate the current overall administrative organization of the University. The documents are:

1. Chart, Administrative Organization, SIUE.
2. Chart, Office of The President.
3. Position and Personnel Listing, Office of The President
4. University Administrative Council.
5. President's Advisory Council.

II. On March 25, 1975, President Rendleman established a year-long Tenth Anniversary Celebration Program, in commemoration of the opening of the Edwardsville campus in September, 1965. A. R. Howard, Director of University News Services, was placed on special assignment, effective April 1, 1975, as director of the Tenth Anniversary Celebration, serving on the staff of the Office of The President and reporting directly to the President. Sam Smith was designated Acting Director of University News Services during the period of Mr. Howard's special assignment.

Responsibility for the continuation of the Tenth Anniversary Celebration Program is hereby transferred to the Senior Vice-President for Planning and Review. A. R. Howard's assignment as Director of News Services is hereby changed to Special Assistant to the Senior Vice-President for Planning and Review, continuing as Director of the Tenth Anniversary Celebration Program.

Sam Smith will continue to function as Acting Director of University News Services.

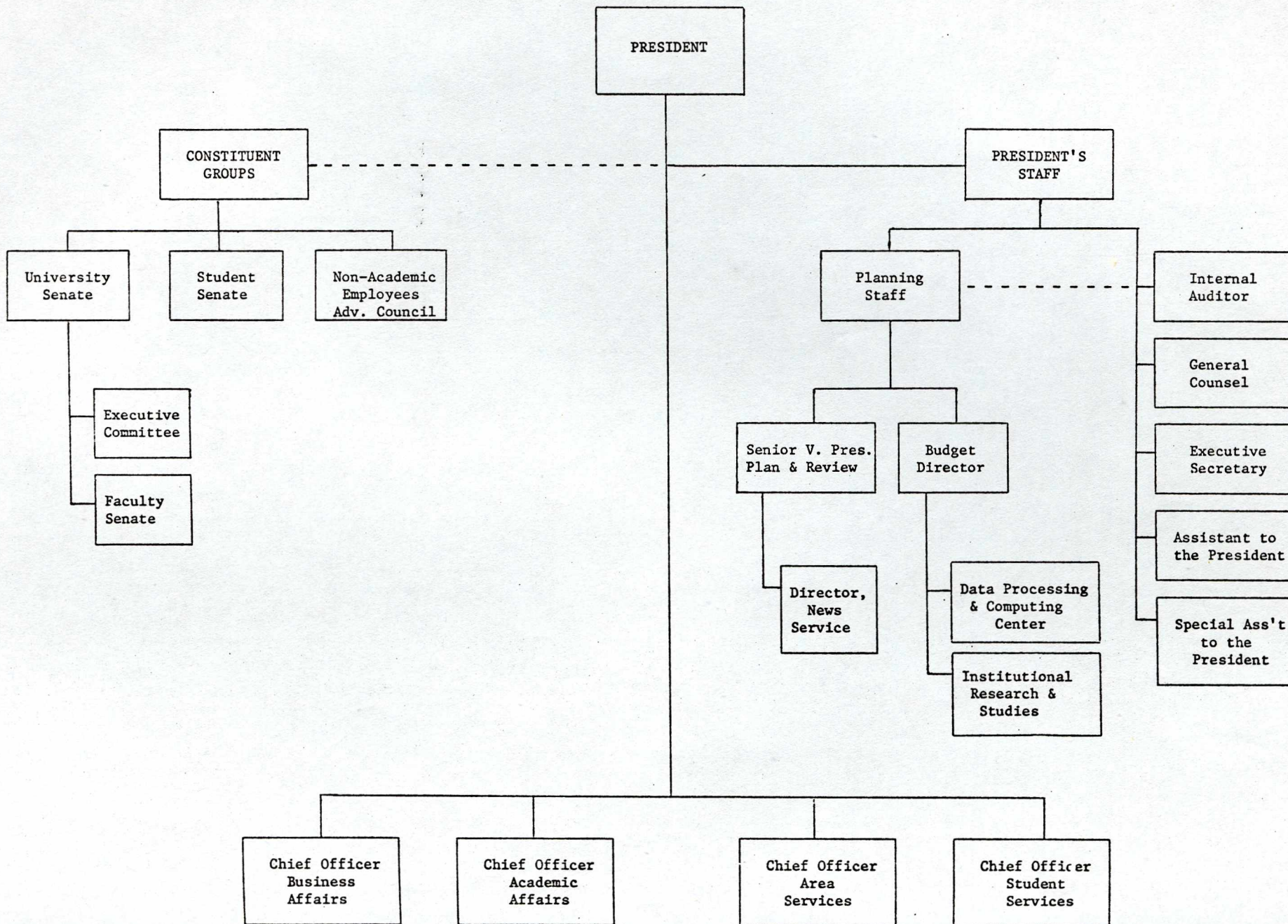
