SUBJECT: Appointment of Provost and Vice President for Academic Affairs

I am pleased to announce the appointment of David J. Werner as Provost and Vice President for Academic Affairs of Southern Illinois University at Edwardsville, effective July 1. The appointment has been ratified by the Chancellor and is contingent upon formal action by the Board of Trustees.

Dr. Werner currently serves as Dean of the SIUE School of Business, a position he has held since 1975. He has been associated with the University since his appointment as an assistant professor in 1969. He presently holds rank in the School of Business as a professor of management information systems and operations management.

Dr. Werner has served in a number of academic, staff, governance and committee roles during his tenure with the University. He has been a continuing member of the University Coordinating Committee for the Center for Advanced Manufacturing and Production and served as acting director of the unit from February until December, 1985. He also is chairman of the Academic Program Committee for University Park.

Dr. Werner has been active in the American Assembly of Collegiate Schools of Business, serving as vice president and program chair of the Mid-Continent East division, and as the chairman of several panel sessions. He has been a member of the Board of Trustees of the Illinois Council on Economic Education, a member of the Operating Board of the Mid-Illinois Computer Consortium, and a consultant-evaluator for the North Central Association.

Dr. Werner received his baccalaureate degree in industrial engineering from St. Louis University and his master's and doctoral degrees in industrial engineering and management science at Northwestern University. He and his wife, Kay, are the parents of three children, and the family resides in Edwardsville.

I look forward to working with Dr. Werner in pursuit of the University's mission.
